Day 1: Core Module; Penetration Seals **09.00 – 17.00**
Day 2: Partitions; Cavity Barriers; Fire Doors **09.00 – 17.00**

Core Module – Introduction to IFC, Building codes, Irish regulations, fire testing. This includes examples of real fires and what went wrong! Issues are explored and explained.

Penetration Seals – how holes are commonly sealed in buildings with examples.

Partitions – fire compartmentation and lightweight systems and ceilings for fire separation.

Cavity Barriers – Specific methods of protecting concealed spaces against the spread of fire and smoke.

Fire Doors – review of Fire Doors and doorsets including the specific components that make up timber fire doors. This will include frame, leaves, smoke and intumescent seals.

The course is designed for two days, it is possible to attend one day, however the core module sets the context for all subsequent modules.

Upon completion of the training, IFC will prepare formal certificates for each attendee of the training undertaken, following successful assessment of the individual modules.
